### 2.1. Information concerning the use of cookies

### 2.2. Data processing inherent with the registration

Legal basis of the data processing	The legal basis of the data processing is your consent pursuant to Point a) of Section 5 (1) of the Privacy Act.

The purpose of the data processing	The Personal Data provided to Progressive Advertising Agency with the completion of the form shall be processed pursuant to Section 5(1) a) of the Information Act subject to the voluntary and prior, detailed informed consent of the person completing the form. Personal Data shall be processed by Progressive Advertising Agency in connection with the job search activities of the person completing the form and for the purpose of contacting and communicating with the same.
The entity authorized to perform data processing and to access Personal Data	Personal Data may only be processed by Progressive Advertising Agency. No Personal Data may be forwarded by Progressive Advertising Agency to third parties, they may only be accessed by Progressive Advertising Agency, as data controller.
The term of the data processing	Personal Data provided to Progressive Advertising Agency by completing the form, may be processed by Progressive Advertising Agency until the purposes of data processing cease to exist or the data subject prohibits such data processing, but only for up to 5 years from the date of receiving such data.

### 2.3. Further data processing

In case the Data Controller intends to perform further data processing, it shall provide preliminary notification on the material circumstances thereof (legal background and legal basis of the data processing, the purpose thereof, the scope of controlled data, the term thereof). We inform you that the Data Controller is obliged to satisfy the written data requests of authorities being based on legal authorization. The Data Controller shall keep register of the data transfers in accordance with Sections 15 (2)-(3) of the Privacy Act (to which authority, what personal data, on what legal basis, when the Data Controller transferred), the content of which the Data Controller shall provide information except if informing you is excluded by law.

### 6.1. During the data processing, you are entitled to:

personal data is necessary exclusively for performing
legal obligation binding the Data Controller, or for
enforcing the legal interest of the Data Controller,
data transferee or third party with the exception in

set forth in Section 6 (5) of the Privacy Act, as well as
(ii) if using or transferring the personal data – without
your consent – takes place direct business acquisition,
public opinion research or scientific research. The
Data Controller shall examine the objection within the
shortest time reckoned from the submission of your
request but at most within 30 days, shall make
decision in its groundedness and shall inform you of
the decision in writing.

#### 6.2. Legal remedies

In case you consider that the Data Controller has violated a legal provision related to data processing or has not satisfied your request, you may initiate the investigation procedure the Hungarian National Authority for Data Protection and Freedom of Information (postal address: 1530 Budapest, P.O. Box: 5., e-mail: ugyfelszolgalat@naih.hu) in order to discontinue the assumed unlawful data processing. We furthermore inform you that, in the event of violating the legal provisions related to data processing or if the Data Controller has not satisfied your request, you may turn to court against the Data Controller.

### 7. REGISTRATION IN THE DATA PROTECTION REGISTRY

Pursuant to the provisions of the Privacy Act, the Data Controller has announced its data processing related to the invitation for the event into the data protection registry, the procedure for entering into the registry is in progress.

Furthermore, you are hereby informed that by completing and submitting the form to Progressive Advertising Agency, you accept and acknowledge the Privacy Policy above, and you also expressly consent to the processing of all data voluntarily provided, including Personal Data, by Progressive Advertising Agency in accordance with the provisions of the applicable law.
